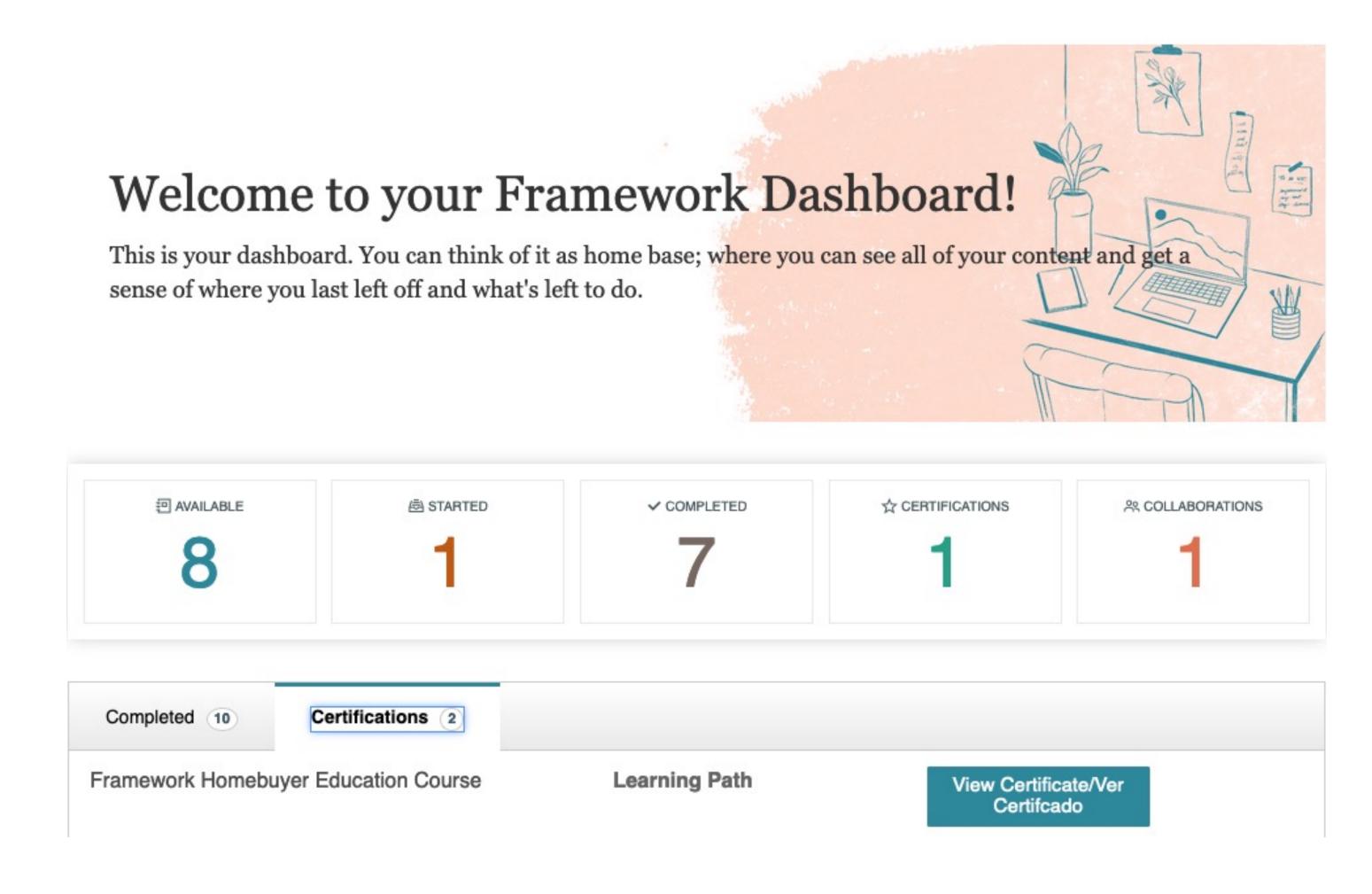

HOW LEARNERS ACCESS CERTIFICATES

Learners must complete all 7 lessons of the course and score at least 80% on each of the lesson quizzes. Once this occurs, one of three things will happen depending on your organization's setup:

- No Certificate Withholding: The learner will receive their certificate of completion and can access this any time from their dashboard by going to the certifications tab and selecting View Certificate. learners also receive an email with a link to the certificate.
- Certificate Withholding: The learner should enter the advising activity and follow the instructions to schedule their appointment and submit their name to the advising approval queue. Once the advising session is marked complete, the learner will receive their certificate of completion and can access this any time from their dashboard by going to the certifications tab and selecting View Certificate. learners also receive an email with a link to the certificate.

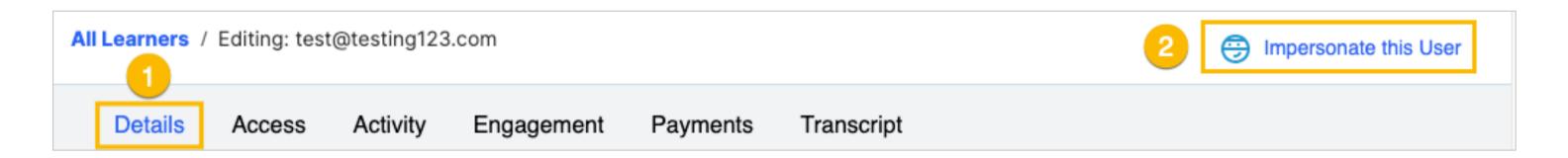




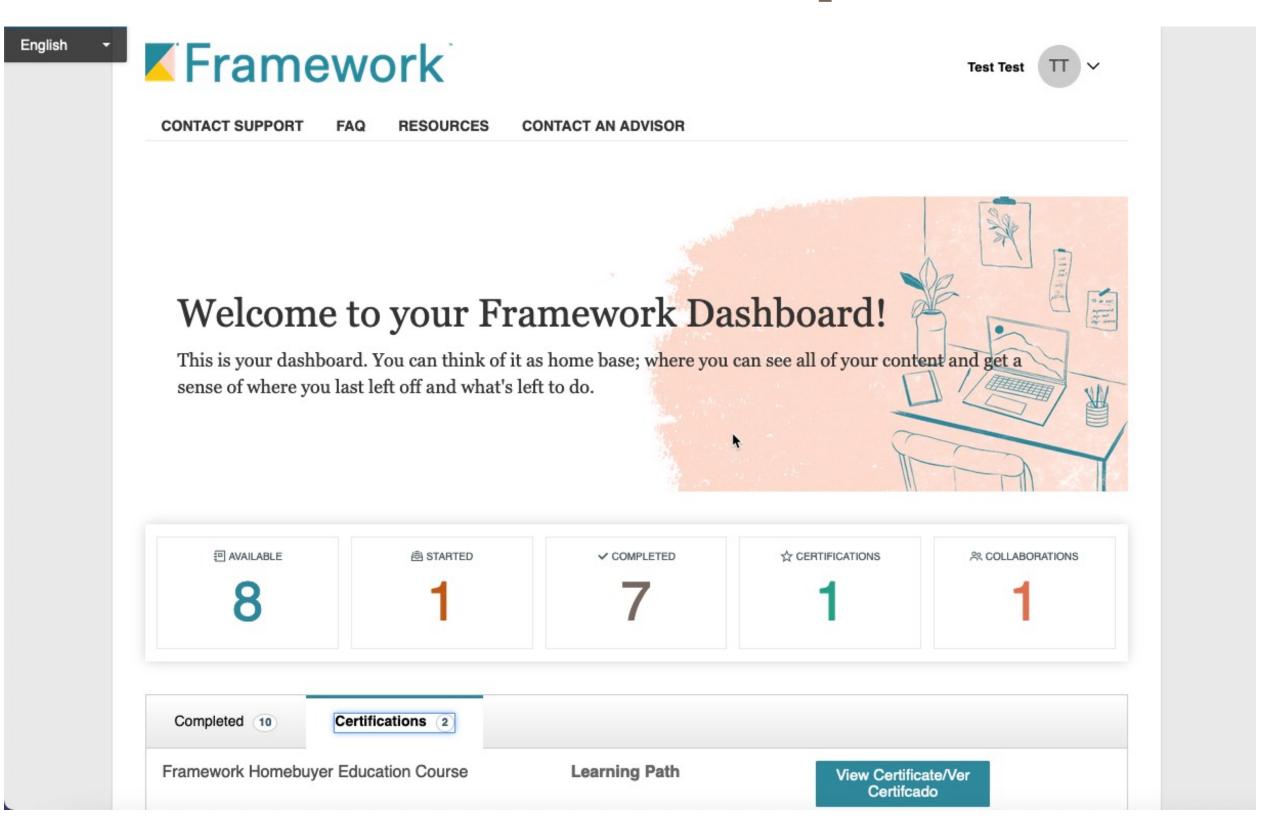
SEE THE LAYOUT YOUR LEARNERS SEE

View Once You've Selected Impersonation:

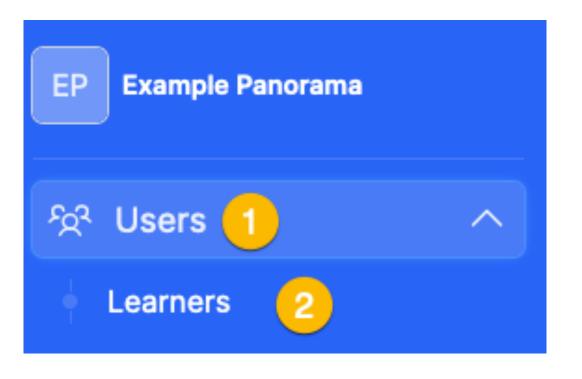


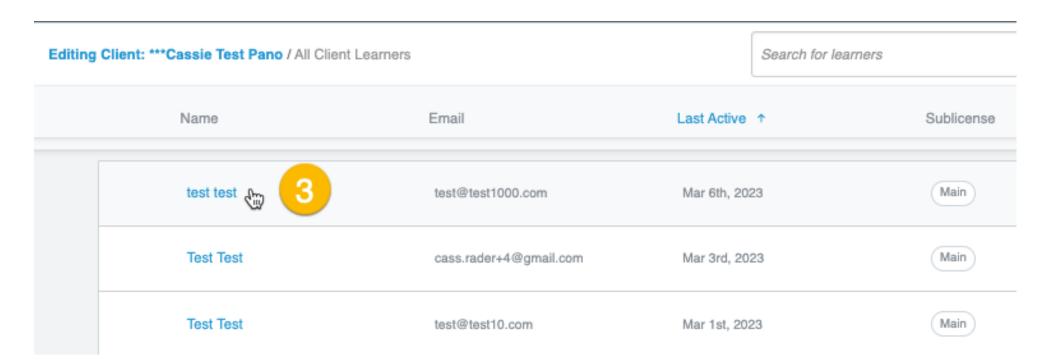

HOW MANAGERS ACCESS LEARNERS' CERTIFICATES

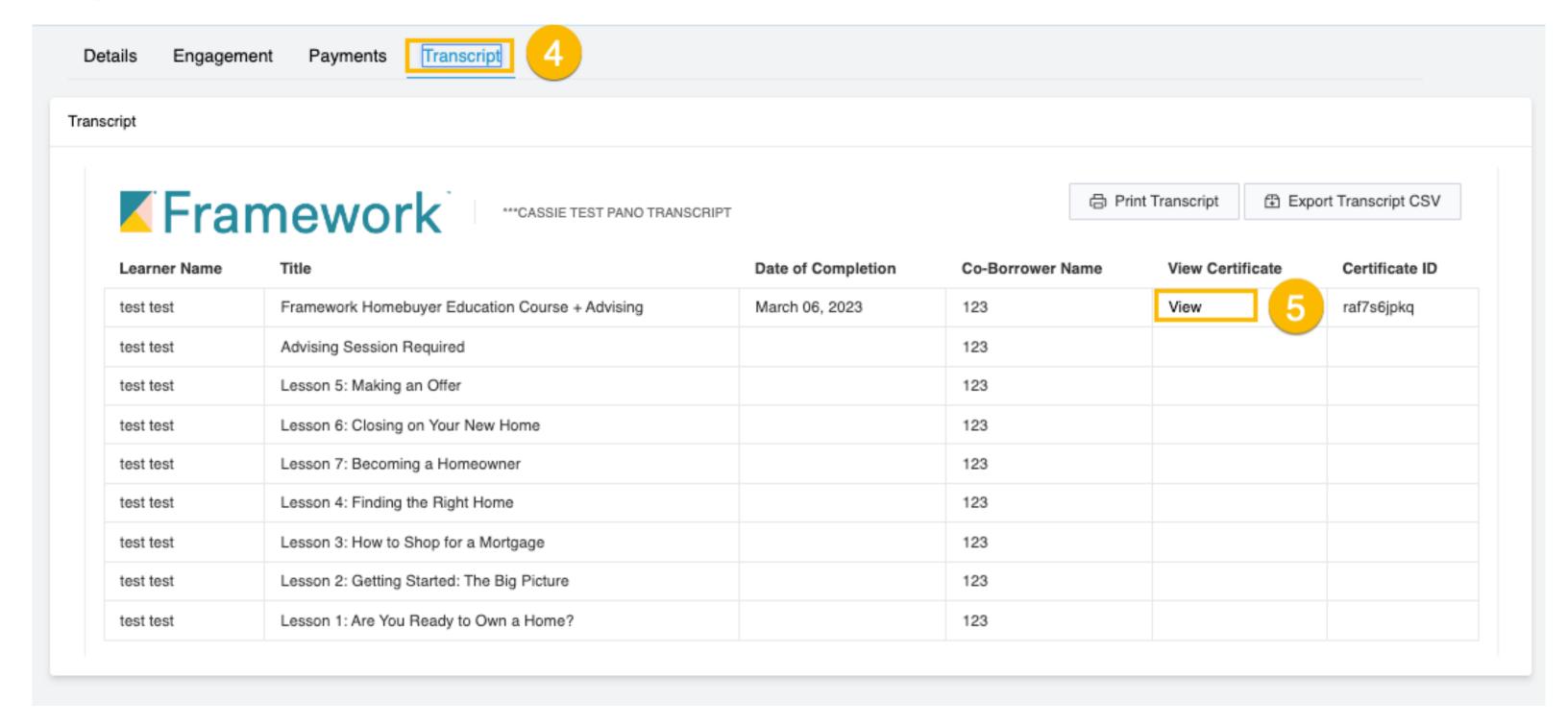
First, log into your LMS manger account

- 1. Select "Users" from the left menu
- 2. Select "Learners"
- 3. Search for then select the learner whose certificate you'd like to view
- 4. Click the tab that says "Transcript"
- 5. Click View Certificate next to the Framework Homebuyer Education

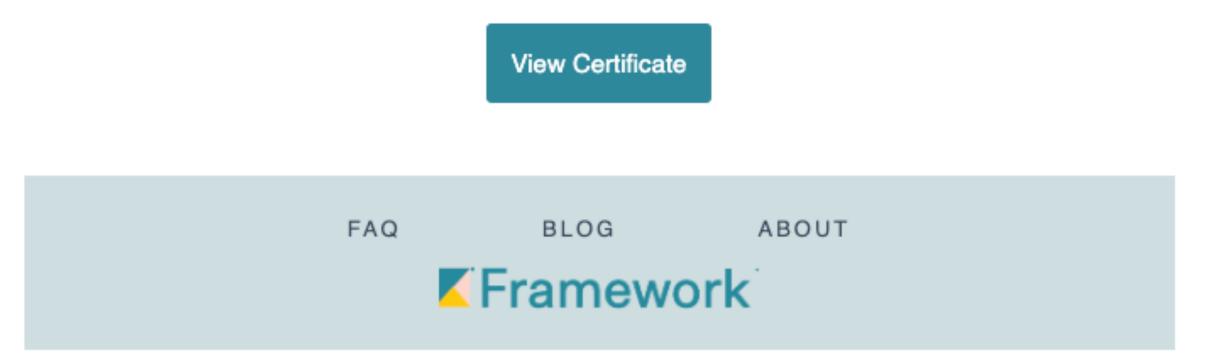
NOTIFICATIONS FOR CERTIFICATES

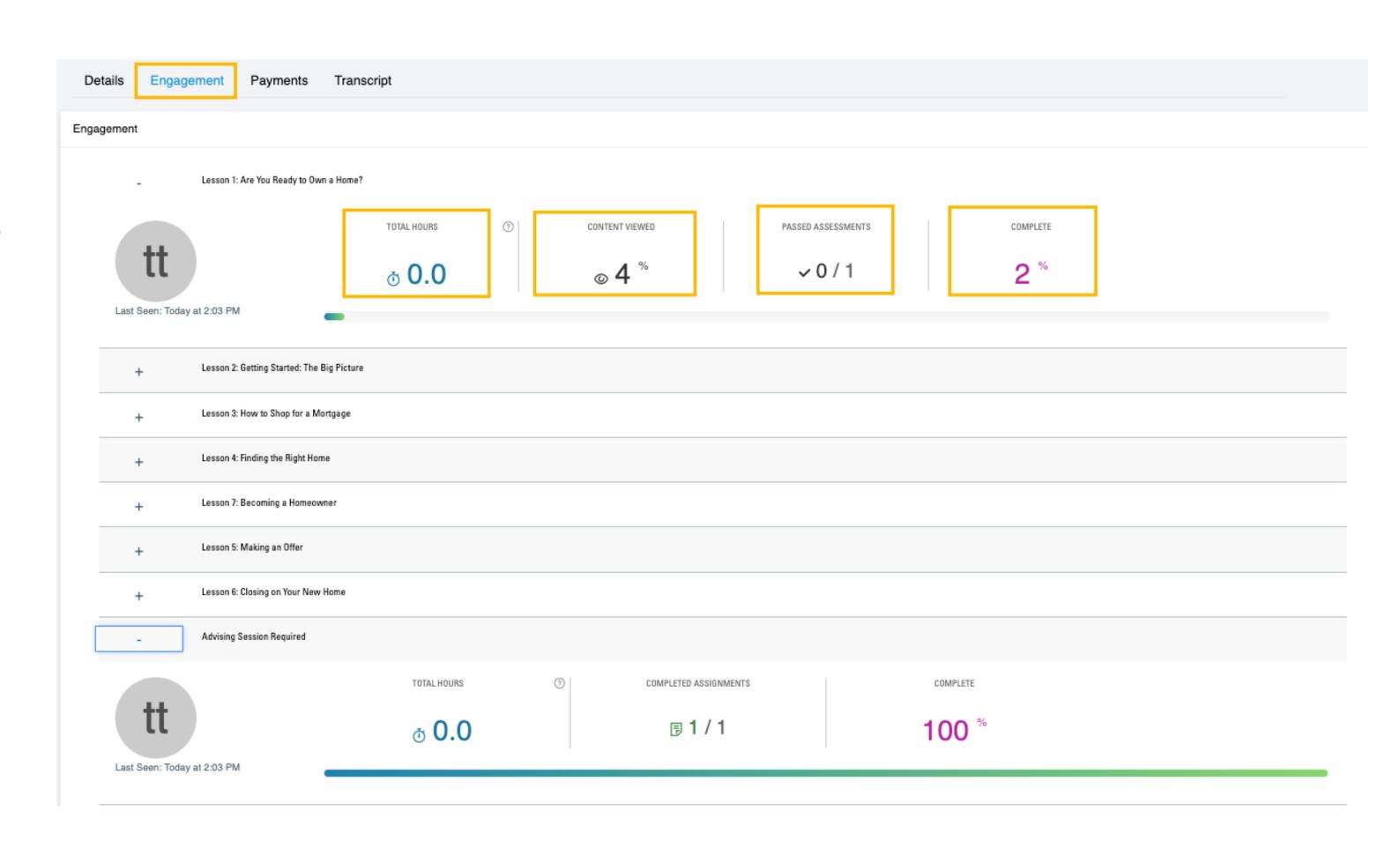

TROUBLESHOOTING CERTIFICATES

Unable to Access the Certificate

- First, check that all seven lessons are complete, and that each quiz has been passed.
 - You can see these details by going to a learner record and selecting the engagement tab. Then you can click on any of the lessons and see how much time a learner has spent and whether they have viewed all the content and passed the assessment (quiz)
- Make sure that the advising session is marked as complete (if applicable)
- If you've verified that all the above have been completed, contact Customer Success





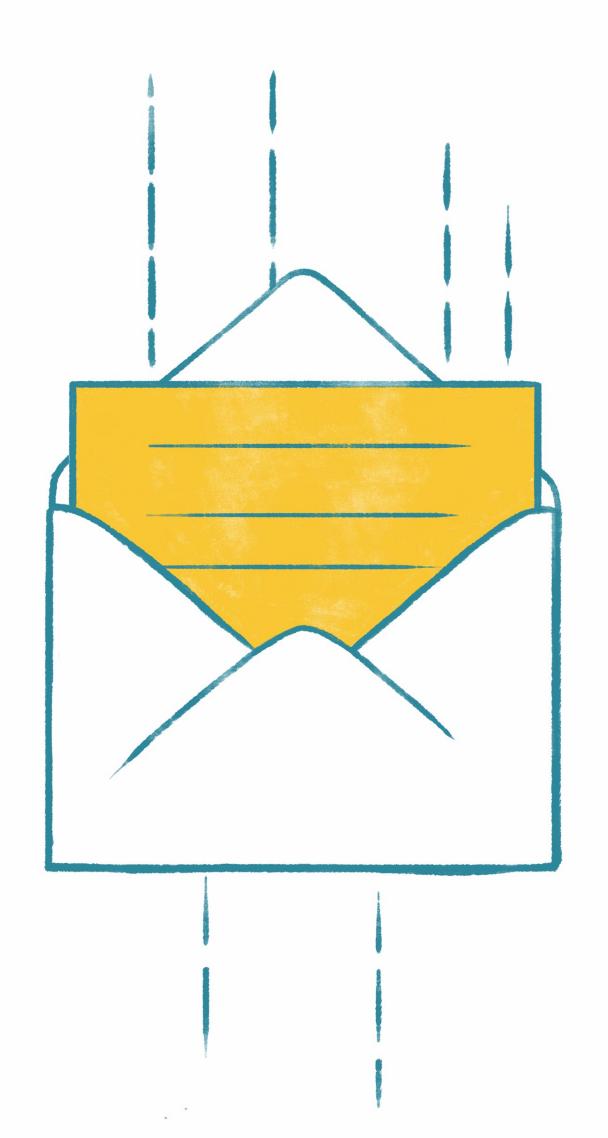
